### DESCRIPTION

CLINI-FRESH is a pleasantly perfumed, water based reodorant, ideally suited for use in rooms, where a pleasant residual odour is required, such as toilets, bathrooms or ablution areas. It binds to the malodour molecules usually found in toilet room and bathrooms resulting in efficient reduction of available malodorous gases and vapours in the air. CLINI-FRESH has excellent residual fragrance properties, lasting for up to 24 hours. It will not sour and its freshness will appeal long after it was applied.

### DIRECTIONS FOR USE

CLINI-FRESH is designed to be applied through a hand spray gun and can be used neat, or diluted 1:5 with water depending on the desired effect. Spray directly onto the source of the malodours or use a general air room freshener.

To prevent microbial contamination, close container immediately after use and do not add or insert any foreign materials or objects.
