DIRECTIONS FOR USE

For best results use in conjunction with Jasol HI FLUX EXCEL. Make sure that pH is 9.0-10.0 and the temperature around 50°C before adding HI FLUX ENZYME QUATRO at 0.2% v/v. Recirculate for at least 20 min. Soaking is recommended if time permits.

Please note that all membrane cleaning must be carried out in accordance with the membrane manufacturer's guidelines, recommended limits of pH, temperature and exposure time should be followed.
