DIRECTIONS FOR USE

Hospital Grade Disinfectant: Dilute 1:15. Pre-clean/wipe surface, apply solution, leave for 10 mins then rinse off. Store unused solution for up to 24 hours at room temperature.

Detergent Reodorant: Dilute 1:100 (hot water) for general purpose mopping floors.

Hard surface disinfectant only. Not to be used on skin.

To prevent microbial contamination, close containers immediately after use and do not add or insert any foreign materials or objects.

EFFICACY

SUPERSCENT T was evaluated in accordance with the TGA Test for Hospital Grade Disinfectants (Option A) and passed the test against the following organisms when was applied at a dilution rate of 1:15:

- Escherichia coli
- Proteus vulgaris
- Pseudomonas aeruginosa
- Staphylococcus aureus

SUPERSCENT T was evaluated by the AOAC Hard Surface Carrier Test 991.47, 48, 49 (modified) at a dilution rate of 1:15 & 10 minutes contact time in standard hard water. The product passed the test against all prescribed organisms:

- Pseudomonas aeruginosa
- Staphylococcus aureus
- Salmonella choleraesuis

SUPERSCENT T was evaluated in accordance with TMCV 006 at a dilution rate of 1:30 & 10 minutes contact time at room temperature. The product passed the test against the following organism:

Murine Hepatitis Virus (MHV)-1 ATCC/VR-261 (TGA designated surrogate to justify COVID-19 efficacy claim).
